The \$50 application fee is waived for currently enrolled families. Classes have limited space. Please enroll as soon as possible, as Open Enrollment for the public begins on March 1st. Enrollment Fees: (to be submitted for re-enrollment)

- \$150 Per Student/\$450 Family Max if paid by April 1st
- \$200 Per student/ \$600 Family if paid by May 31st
- \$250 Per Student/ No Family Max if paid by Aug 22nd
- \$400 Per Student If after Aug 22nd

Tuition Information

Monthly tuition payments are due on the 1st and are payable until the 15th of each month, beginning in June and continuing through April for an 11 month payment plan. Late Payments will incur a **\$25** late fee per month. **All students must have completed registration, paid their enrollment fee and a minimum of 3 month's tuition payments prior to attending classes.** Families with past due accounts may not re-enroll students until their account is up to date.

Early Withdrawal Fee

When families enroll a child, they commit to pay the expenses of the student for the full year, allowing the school to commit resources (teacher salaries, supplies, etc.) to teach that child. When parents withdraw a student early, it breaks that commitment and introduces a financial challenge to the school, which must still meet its obligations. Therefore, an Early Withdrawal Fee will apply to students who withdraw early and past due accounts must be made current at the time of withdrawal.
